## CERTIFICATION OF REPRESENTATIVES

Pursuant to a Consent Election by and between Dept. of Social Welfare (Div. of Public Assistance and Div. of Child Welfare Services and Rhode Island Alliance of Public Social Workers and R. I. State Employees Association the Rhode Island State Labor Relations Board held an election on September 20, 1967

by secret ballot of all Social Caseworkers and Professionally Trained Caseworkers employed by the Dept. of Social Welfare excluding Public Assistance Administrator, Chief Public Assistance Supervisor, Senior Public Assistance Supervisors, Chief Medical Assistance Supervisor, Social Audit Supervisor, Administrator Child Welfare Services, Chief Child Welfare Services Supervisor, Chief Child Licensing Supervisor, and Senior Casework Supervisor

On the basis of the election of said employees as aforesaid, the Rhode Island Alliance of Public Social Workers

has been designated by a majority of said employees of Department of Social Welfare (Div. of Public Assistance & Div. of Child Welfare Services) as their bargaining representative.

The Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by 28-7-16, General Laws of Rhode Island, 1956, it is hereby:

CERTIFIED, that the Rhode Island Alliance of Public Social Workers has been designated and selected by a majority of the Social Caseworkers and Professionally Trained Caseworkers employed by the Dept. of Social Welfare excluding Public Assistance Administrator, Chief Public Assistance Supervisor, Senior Public Assistance Supervisors, Chief Medical Assistance Supervisor, Social Audit Supervisor, Administrator Child Welfare Services, Chief Child Welfare Services Supervisor, Chief Child Licensing Supervisor, and Senior Casework Supervisor

as their sole representative for the purpose of collective bargaining and that pursuant to the provisions of 28-7-16, (1) of the Act, the Rhode Island Alliance of Public Social Workers

is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
