CERTIFICATION OF REPRESENTATIVES

Pursuant to an Ordered Election by and between Pawtucket School Department and Pawtucket Teachers Alliance Local #930 AFT-AFL-CIO

the Rhode Island State Labor Relations Board held an election on May 3, 1967

Dir. of Guidance, Supervising Dir. of Special Serv.'s, Supervising Dir. of Music, Supervising Dir. of Physical Edu., Teaching Supervisor of Sec.'al Studies, Serv. Dir. of Audio-Visual Edu., Dir. of Elementary Edu., and Attendance Officer

On the basis of the election of said employees as aforesaid, the Pawtucket Teachers Alliance Local #930 AFT-AFL-CIO

has been designated by a majority of said employees of Pawtucket School Department as their bargaining representative.

The Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 6, of the Rhode Island State Labor Relations Act, Chapter 1066 of the Public Laws of 1941, as amended, it is hereby:

CERTIFIED, that the Pawtucket Teachers Alliance Local #930 AFT-AFL-CIO has been designated and selected by a majority of the certified teaching personnel who are engaged in teaching duties employed by the Pawt. School Dept. excluding the Supt., Asst. Supt., Prin.'s, Asst. Prin.'s, Supervising Dir. of Art, Dir. of Curriculum, Serv. Dir. of Guidance, Supervising Dir. of Special Serv.'s, Supervising Dir. of Music, Supervising Dir. of Physical Edu., Teaching Supervisor of Sec.'al Studies, Serv. Dir. of Audio-Visual Edu., Dir. of Elementary Edu., and Attendance Officer

as their sole representative for the purpose of collective bargaining and that pursuant to the provisions of Section 6, subdivision 1, of the Act, the Pawtucket Teachers Alliance Local #930 AFT-AFL-CIO

is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
