AMENDED CERTIFICATION OF REPRESENTATIVES

Pursuant to an Ordered Election by and between the **State of Rhode Island – Narragansett Bay Commission** and **RI Council 94, AFSCME, AFL-CIO, Local 2884** and Rhode Island State Employees Association, the Rhode Island State Labor Relations Board held an election on February 2, 1968 by secret ballot of: All employees of the **State of Rhode Island – Narragansett Bay Commission**, excluding the Commissioners, the Executive Secretary, Senior Accountant, Accountants, Chemical Engineer, Maintenance Engineer, Administrative Assistant and supervisors.

On the basis of the election of said employees as aforesaid, **RI Council 94, AFSCME, AFL-CIO, Local 2884** has been designated by a majority of said employees of the **State of Rhode Island – Narragansett Bay Commission** as their bargaining representative.

That on April 17, 2020, a request was received from R. I. Public Employees Council 70, AFSCME, AFL-CIO (**Rhode Island Council 94, AFSCME, AFL-CIO**) that the above-entitled certification be amended to reflect the identity change of the party’s representatives.

That on May 19, 2020, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the identity change of the party’s representatives, to read: **State of Rhode Island – Narragansett Bay Commission and RI Council 94, AFSCME, AFL-CIO, Local 2884** and R.I. State Employees Association.

THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that **RI Council 94, AFSCME, AFL-CIO, Local 2884** has been designated and selected by a majority of: All employees of the **State of Rhode Island – Narragansett Bay Commission**, excluding the Commissioners, the Executive Secretary, Senior Accountant, Accountants, Chemical Engineer, Maintenance Engineer, Administrative Assistant and supervisors, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, **RI Council 94, AFSCME, AFL-CIO, Local 2884** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
