AMENDED CERTIFICATION OF REPRESENTATIVES

Pursuant to a Consent Election by and between the City of Warwick and **RI Council 94, AFSCME, AFL-CIO, Local 1651**, the Rhode Island State Labor Relations Board held an election on August 3, 1967, by Comparison of Signatures of: All employees of the following employers: City of Warwick, City of Warwick Sewer Authority, City of Warwick Board of Canvassers, and City of Warwick Waterfront Development and Park Commission, but excluding uniformed policemen and firemen, school department employees, librarians and all supervisory, administrative and professional employees.

On the basis of the Comparison of Signatures of said employees as aforesaid, **RI Council 94, AFSCME, AFL-CIO, Local 1651** has been designated by a majority of said employees of the City of Warwick as their bargaining representative.


That on November 7, 2019, a request was received from the Rhode Island Public Employees, Council 70, AFSCME, AFL-CIO, (**RI Council 94, AFSCME, AFL-CIO**) that the above-entitled certification be amended to reflect the identity change of the Union representative.


That on December 10, 2019, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the identity change of the Union representative, to read: City of Warwick and **RI Council 94, AFSCME, AFL-CIO, Local 1651**.


THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:


CERTIFIED, that **RI Council 94, AFSCME, AFL-CIO, Local 1651** has been designated and selected by a majority of: All employees of the following employers: City of Warwick, City of Warwick Sewer Authority, City of Warwick Board of Canvassers, and City of Warwick Waterfront Development and Park Commission, but excluding uniformed policemen and firemen, school department employees, librarians and all supervisory, administrative and professional employees, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, **RI Council 94, AFSCME, AFL-CIO, Local 1651** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
