AMENDED CERTIFICATION OF REPRESENTATIVES

Pursuant to an Ordered Election by and between the State of Rhode Island – Department of Administration, Rhode Island State Employees Association and **RI Council 94, AFSCME, AFL-CIO, Local 2448**, the Rhode Island State Labor Relations Board held an election on June 21 – June 25, 1971, by secret ballot of: All employees within the Department, excluding supervisory and professional employees.

On the basis of the election of said employees as aforesaid, **RI Council 94, AFSCME, AFL-CIO, Local 2448** has been designated by a majority of said employees of the State of Rhode Island – Department of Administration, as their bargaining representative.






That on December 4, 2019, a request was received from AFSCME, Council 70, AFL-CIO, (**RI Council 94, AFSCME, AFL-CIO**) that the above-entitled certification be amended to reflect the identity change of the Union representative.

That on December 10, 2019, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the identity change of the Union representative, to read: State of Rhode Island – Department of Administration and R.I. State Employees Association and **RI Council 94, AFSCME, AFL-CIO, Local 2448**.

THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that **RI Council 94, AFSCME, AFL-CIO, Local 2448** has been designated and selected by a majority of: All employees within the Department, excluding supervisory and professional employees, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, **RI Council 94, AFSCME, AFL-CIO, Local 2448** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
