AMENDED CERTIFICATION OF REPRESENTATIVES

Pursuant to a Consent Election by and between the **State of Rhode Island – Department of Labor & Training** and Rhode Island State Employees Association and **RI Council 94, AFSCME, AFL-CIO, Local 2869**, the Rhode Island State Labor Relations Board held an election on June 29, 1967 by secret ballot of: All Departmental employees, excluding Director, Deputy Director, Administrative Assistant to Director, Confidential Secretary to Director, Executive Secretary, Assistant Executive Secretary to the State Labor Relations Board and Conciliators and Doctors employed by the Rhode Island Curative Center, Executive Assistant to Curative Center and Division Chiefs.

On the basis of the election of said employees as aforesaid, **RI Council 94, AFSCME, AFL-CIO, Local 2869** has been designated by a majority of said employees of the **State of Rhode Island – Department of Labor & Training** as their bargaining representative.

That on April 17, 2020, a request was received from Rhode Island Public Employees Council 70, AFSCME, AFL-CIO (**Rhode Island Council 94, AFSCME, AFL-CIO**) that the above-entitled certification be amended to reflect the identity change of the party’s representatives.

That on May 19, 2020, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the identity change of the party’s representatives, to read: **State of Rhode Island – Department of Labor & Training** and Rhode Island State Employees Association and **RI Council 94, AFSCME, AFL-CIO, Local 2869**.

**THEREFORE**, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

**CERTIFIED**, that **RI Council 94, AFSCME, AFL-CIO, Local 2869** has been designated and selected by a majority of: All Departmental employees, excluding Director, Deputy Director, Administrative Assistant to Director, Confidential Secretary to Director, Executive Secretary, Assistant Executive Secretary to the State Labor Relations Board and Conciliators and Doctors employed by the Rhode Island Curative Center, Executive Assistant to Curative Center and Division Chiefs, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, **RI Council 94, AFSCME, AFL-CIO, Local 2869** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
