AMENDED CERTIFICATION OF REPRESENTATIVES

Pursuant to a Consent Election by and between the **Newport School Committee** (all non-teaching personnel, except supervisors) and **RI Council 94, AFSCME, AFL-CIO, Local 841**, the Rhode Island State Labor Relations Board held an election on June 20, 1967, by Comparison of Signatures of: All non-teaching personnel, except supervisors.

On the basis of the Comparison of Signatures of said employees as aforesaid, **RI Council 94, AFSCME, AFL-CIO, Local 841** has been designated by a majority of said employees of the **Newport School Committee** (all non-teaching personnel, except supervisors), as their bargaining representative.

That on October 11, 2019, a request was received from the Rhode Island Public Employees, Council 70, AFSCME, AFL-CIO, (**RI Council 94, AFSCME, AFL-CIO**) that the above-entitled certification be amended to reflect the identity change of the party's representatives.

That on November 12, 2019, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the identity change of the party's representatives, to read: **Newport School Committee and RI Council 94, AFSCME, AFL-CIO, Local 841**.

THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that **RI Council 94, AFSCME, AFL-CIO, Local 841** has been designated and selected by a majority of: All non-teaching personnel, except supervisors, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, **RI Council 94, AFSCME, AFL-CIO, Local 841** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
