**AMENDED CERTIFICATION OF REPRESENTATIVES**

Pursuant to a Consent Election by and between **Tiverton School Committee** and **RI Council 94, AFSCME, AFL-CIO, Local 2670**, the Rhode Island State Labor Relations Board held an election on June 28, 1967, by secret ballot of: All non-teaching personnel, excluding supervisors.

On the basis of the election of said employees as aforesaid, **RI Council 94, AFSCME, AFL-CIO, Local 2670** has been designated by a majority of said employees of the **Tiverton School Committee**, as their bargaining representative.


That on September 27, 2019, a request was received from Rhode Island Public Employees, Council 70, AFSCME, AFL-CIO, (**RI Council 94, AFSCME, AFL-CIO**) that the above-entitled certification be amended to reflect the identity change of the party's representatives.

That on October 8, 2019, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the identity change of the party's representatives, to read: **Tiverton School Committee and RI Council 94, AFSCME, AFL-CIO, Local 2670**.


**THEREFORE**, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:


**CERTIFIED**, that **RI Council 94, AFSCME, AFL-CIO, Local 2670** has been designated and selected by a majority of: All non-teaching personnel, excluding supervisors, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, **RI Council 94, AFSCME, AFL-CIO, Local 2670** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
