AMENDED CERTIFICATION OF REPRESENTATIVES

Pursuant to a Consent Election by and between the **City of Pawtucket** and **RI Council 94, AFSCME, AFL-CIO, Local 1012**, the Rhode Island State Labor Relations Board held an election on September 22, 1967, by secret ballot of: All employees of the City of Pawtucket, except those excluded under Chapter 9.4-2 of Title 28 of the General Laws of R.I.

On the basis of the election of said employees as aforesaid, **RI Council 94, AFSCME, AFL-CIO, Local 1012** has been designated by a majority of said employees of the **City of Pawtucket** as their bargaining representative.


That on October 16, 2019, a request was received from the Rhode Island Public Employees, Council 70, AFSCME, AFL-CIO, (**RI Council 94, AFSCME, AFL-CIO**) that the above-entitled certification be amended to reflect the identity change of the party's representatives.

That on November 12, 2019, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the identity change of the party's representatives, to read: **City of Pawtucket and RI Council 94, AFSCME, AFL-CIO, Local 1012**.


THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that **RI Council 94, AFSCME, AFL-CIO, Local 1012** has been designated and selected by a majority of: All employees of the City of Pawtucket, except those excluded under Chapter 9.4-2 of Title 28 of the General Laws of R.I., as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, **RI Council 94, AFSCME, AFL-CIO, Local 1012** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.


