**AMENDED CERTIFICATION OF REPRESENTATIVES**

Pursuant to a Consent Election by and between the **Pawtucket School Committee** and **RI Council 94, AFSCME, AFL-CIO, Local 1352**, the Rhode Island State Labor Relations Board held an election on February 28, 1968, by comparison of signatures and payroll deductions of: All non-teaching personnel employed by the Pawtucket School Committee, excluding School Business Manager, School Plant Supervisor, Chief Custodian, Confidential Secretary to the Superintendent of Schools and Confidential Secretary to Deputy Superintendent of Schools.

On the basis of the comparison of signatures and payroll deductions of said employees as aforesaid, **RI Council 94, AFSCME, AFL-CIO, Local 1352** has been designated by a majority of said employees of the **Pawtucket School Committee**, as their bargaining representative.

That on September 26, 2019, a request was received from the Rhode Island Public Employees, Council 70, AFSCME, AFL-CIO, (**RI Council 94, AFSCME, AFL-CIO**) that the above-entitled certification be amended to reflect the identity change of the party's representatives.

That on October 8, 2019, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the identity change of the party's representatives, to read: **Pawtucket School Committee and RI Council 94, AFSCME, AFL-CIO, Local 1352**.

**THEREFORE**, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

**CERTIFIED**, that **RI Council 94, AFSCME, AFL-CIO, Local 1352** has been designated and selected by a majority of: All non-teaching personnel employed by the Pawtucket School Committee, excluding School Business Manager, School Plant Supervisor, Chief Custodian, Confidential Secretary to the Superintendent of Schools and Confidential Secretary to Deputy Superintendent of Schools, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, **RI Council 94, AFSCME, AFL-CIO, Local 1352** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
