**AMENDED CERTIFICATION OF REPRESENTATIVES**

Pursuant to a Consent Election by and between **Rhode Island Airport Corporation** and **RI Council 94, AFSCME, AFL-CIO, Local 2873**, the Rhode Island State Labor Relations Board held an election on July 16 – July 17, 1968, by secret ballot of: All employees within the Division of Aeronautics, excluding Professional employees and supervisors according to attached list.

On the basis of the election of said employees as aforesaid, **RI Council 94, AFSCME, AFL-CIO, Local 2873** has been designated by a majority of said employees of the **Rhode Island Airport Corporation**, as their bargaining representative.


That on September 27, 2019, a request was received from Rhode Island State Employees Association, (**RI Council 94, AFSCME, AFL-CIO**) that the above-entitled certification be amended to reflect the identity change of the party's representatives.






**CERTIFIED**, that **RI Council 94, AFSCME, AFL-CIO, Local 2873** has been designated and selected by a majority of: All employees within the Division of Aeronautics, excluding Professional employees and supervisors according to attached list, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, **RI Council 94, AFSCME, AFL-CIO, Local 2873** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
