AMENDED CERTIFICATION OF REPRESENTATIVES

Pursuant to an Ordered Election by and between the **State of Rhode Island – Department of Behavioral Healthcare, Developmental Disabilities and Hospitals – RI Community Living & Supports (RICLAS)** and the **RI Council 94, AFSCME, AFL-CIO, Local 1293, RICLAS Employees**, the Rhode Island State Labor Relations Board held an election on May 27, 1969 by secret ballot of: all personnel excluding professional and top-level supervisory personnel.

On the basis of the election of said employees as aforesaid, the **RI Council 94, AFSCME, AFL-CIO, Local 1293, RICLAS Employees** has been designated by a majority of said employees of the **State of Rhode Island Department of Behavioral Healthcare, Developmental Disabilities and Hospitals - RI Community Living & Supports (RICLAS)** as their bargaining representative.

That on July 31, 2019, a request was received from the **RI Council 94, AFSCME, AFL-CIO, Local 1293, RICLAS Employees**, that the above-entitled Certification of Representatives be amended to reflect the name changes of the Bargaining Unit Representative, as well as the Employer.

That on September 10, 2019, after review and discussion, the Rhode Island State Labor Relations Board accepted the request for amendment to the said Certification of Representatives, reflecting the name changes as follows: **State of Rhode Island – Department of Behavioral Healthcare, Developmental Disabilities and Hospitals – RI Community Living & Supports (RICLAS)**, and **RI Council 94, AFSCME, AFL-CIO, Local 1293, RICLAS Employees**.


The Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 6, Subdivision 1 of the Rhode Island State Labor Relations Act, Chapter 1066 of the Public Laws of 1941, as amended, it is hereby:

CERTIFIED that the **RI Council 94, AFSCME, AFL-CIO, Local 1293, RICLAS Employees** has been designated and selected by a majority of: all personnel excluding professional and top-level supervisory personnel as their sole representative for the purpose of collective bargaining and that pursuant to the provisions of Section 6, Subdivision 1, of the Act, and that the **RI Council 94, AFSCME, AFL-CIO, Local 1293, RICLAS Employees** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment, and other conditions of employment.


