CERTIFICATION OF REPRESENTATIVES

Pursuant to a Consent Election by and between North Providence School Committee and North Providence Federation of Teachers, Local 920, AFL-CIO the Rhode Island State Labor Relations Board held an election on December 11, 1969

On the basis of the election of said employees as aforesaid, the North Providence Federation of Teachers, Local 920, AFL-CIO has been designated by a majority of said employees of North Providence School Committee as their bargaining representative.

The Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by 28-7-16, General Laws of Rhode Island, 1956, it is hereby:

CERTIFIED, that the North Providence Federation of Teachers, Local 920, AFL-CIO has been designated and selected by a majority of the Athletic coaches and extra-curricular positions (SEE ATTACHED LIST) including any other similar positions that may be created by the North Providence School Committee but excluding all other employees employed by the North Providence School Committee

as their sole representative for the purpose of collective bargaining and that pursuant to the provisions of 28-7-16, (1) of the Act, the North Providence Federation of Teachers, Local 920, AFL-CIO

is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
