**AMENDED CERTIFICATION OF REPRESENTATIVES**

Pursuant to a Consent Election by and between the **State of Rhode Island – Department of Environmental Management** (all employees in the **Department of Environmental Management**, excluding all top level supervisory personnel) and **RI Council 94, AFSCME, AFL-CIO, Local 2881**, the Rhode Island State Labor Relations Board held an election on April 3, 1970, by Comparison of Signatures and Payroll Deductions of: All employees in the **Department of Environmental Management**, excluding all top level supervisory personnel.

On the basis of the Comparison of Signatures and Payroll Deductions of said employees as aforesaid, **RI Council 94, AFSCME, AFL-CIO, Local 2881** has been designated by a majority of said employees of the **State of Rhode Island – Department of Environmental Management** as their bargaining representative.


That on December 18, 2019, a request was received from R.I. State Employees Association (**RI Council 94, AFSCME, AFL-CIO**) that the above-entitled certification be amended to reflect the identity change of the party's representatives.


That on January 14, 2020, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the identity change of the party's representatives, to read: **State of Rhode Island – Department of Environmental Management and RI Council 94, AFSCME, AFL-CIO, Local 2881**.


**THEREFORE**, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:


**CERTIFIED**, that **RI Council 94, AFSCME, AFL-CIO, Local 2881** has been designated and selected by a majority of: All employees in the **Department of Environmental Management**, excluding all top level supervisory personnel, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, **RI Council 94, AFSCME, AFL-CIO, Local 2881** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.


