**CERTIFICATION OF REPRESENTATIVES**

Pursuant to a Consent Election by and between The Providence Housing Authority (All Supervisory and Professional Employees, including; Management Supervisor, Managers, Assistant Manager, Accountant (A), Accountant (B), Comptroller, Sec. to Executive Director, Supervisor of Maintenance & Development, Assistant Supervisor of Maintenance, Foreman of Maintenance, Supervisor of Tenant Applications, Intergroup Relations Officer, Social Service Coordinator, Administrative Assistant) and Local Union #64, a/w The International Brotherhood of Teamsters, C.W. & Helpers of America, the Rhode Island State Labor Relations Board held an election on January 29, 1971 by Comparison of Signatures of: All Supervisory and Professional Employees, including; Management Supervisor, Manager, Assistant Managers, Accountant (A), Accountant (B), Comptroller, Sec. to Executive Director, Supervisor of Maintenance & Development, Assistant Supervisor of Maintenance, Foreman of Maintenance, Supervisor of Tenant Applications, Intergroup Relations Officer, Social Service Coordinator, Administrative Assistant employed by The Providence Housing Authority.

On the basis of the Comparison of Signatures of said employees as aforesaid, the **General Teamsters Local 251**, has been designated by a majority of said employees of The Providence Housing Authority (All Supervisory and Professional Employees, including; Management Supervisor, Managers, Assistant Managers, Accountant (A), Accountant (B), Comptroller, Sec. to Executive Director, Supervisor of Maintenance & Development, Assistant Supervisor of Maintenance, Foreman of Maintenance, Supervisor of Tenant Applications, Intergroup Relations Officer, Social Service Coordinator, Administrative Assistant), as their bargaining representative.

That on April 13, 2017, a request was received from the **General Teamsters Local 251**, that the above-entitled certification be amended to reflect the name change of the Bargaining Unit Representative.

That on June 6, 2017, after review and discussion, the Rhode Island State Labor Relations Board accepted the request for amendment to this certification, reflecting the change in Bargaining Unit Representative name, to read: **General Teamsters Local 251**.

The Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

**CERTIFIED**, that **General Teamsters Local 251** has been designated and selected by a majority of: All Supervisory and Professional Employees, including; Management Supervisor, Managers, Assistant Managers, Accountant (A), Accountant (B), Comptroller, Sec. to Executive Director, Supervisor of Maintenance & Development, Assistant Supervisor of Maintenance, Foreman of Maintenance, Supervisor of Tenant Applications, Intergroup Relations Officer, Social Service Coordinator, Administrative Assistant employed by The Providence Housing Authority, as their sole representative for the purpose of collective bargaining and that pursuant to the provisions of Section 28-7-16 of the Act, **General Teamsters Local 251** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.


