AMENDED CERTIFICATION OF REPRESENTATIVES

Pursuant to a Consent Election by and between the State of Rhode Island, State Agency for Elementary and Secondary Education (all teachers certified to teach driver education) and the Association of Certified Teachers of Driver Education, affiliated with the Rhode Island Federation of Teachers and Rhode Island Education Association, the Rhode Island State Labor Relations Board held an election on June 2, 1971 by Comparison of Signatures of: All teachers certified to teach driver education.

On the basis of the Comparison of Signatures of said employees as aforesaid, the Association of Certified teachers of Driver Education, Affiliated with the Rhode Island Federation of Teachers and RI Education Association, has been designated by a majority of said employees of the State of Rhode Island, State Agency for Elementary and Secondary Education (all teachers certified to teach driver education), as their bargaining representative.

That on November 9, 2004, a request was received from the RI Board of Governors for Higher Education, that the above-entitled certification be amended to reflect the identity change of the Employer in accordance with the changes in R.I.G.L. 31-10-20.

That in addition to the change in the Employer's identity, the certification will reflect an editorial name change for the RI Education Association of: the National Education Association of RI (NEARI).

That on December 14, 2004, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the change in Employer to read: the RI Board of Governors for Higher Education based on the amendment of law, R.I.G.L. 31-10-20 and the editorial name change for NEARI.

THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that the Association of Certified Teachers of Driver Education, Affiliated with the Rhode Island Federation of Teachers and the National Education Association of RI (NEARI) has been designated and selected by a majority of: All teachers certified to teach driver education employed in the State of Rhode Island, RI Board of Governors for Higher Education, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of Section 28-7-16 of the Act, the Association of Certified Teachers of Driver Education, Affiliated with the Rhode Island Federation of Teachers and National Education Association of RI (NEARI) is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
