AMENDED CERTIFICATION OF REPRESENTATIVES

Pursuant to an Consent Election by and between the **Lincoln Public Schools**, and **RI Council 94, AFSCME, AFL-CIO, Local 2671**, the Rhode Island State Labor Relations Board held an election on November 15, 1971, by secret ballot of: All Employees of the School Department including, but not limited to: Clerks, Janitors, Custodians, Bus Drivers, Secretaries, Matrons, Maintenance Mechanics, Teacher Aides, Library Clerks; excluding Supervisors, Technical Aides and Certified Teaching Personnel.

On the basis of the election of said employees as aforesaid, **RI Council 94, AFSCME, AFL-CIO, Local 2671** has been designated by a majority of said employees of **Lincoln Public Schools**, as their bargaining representative.


That on September 18, 2019, a request was received from the Council 70, American Federation State, County & Municipal Employees AFL-CIO, (**RI Council 94, AFSCME, AFL-CIO**) that the above-entitled certification be amended to reflect the identity change of the party's representatives.

That on October 8, 2019, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the identity change of the party's representatives, to read: **Lincoln Public Schools and RI Council 94, AFSCME, AFL-CIO, Local 2671**.


THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that **RI Council 94, AFSCME, AFL-CIO, Local 2671** has been designated and selected by a majority of: All Employees of the School Department including, but not limited to: Clerks, Janitors, Custodians, Bus Drivers, Secretaries, Matrons, Maintenance Mechanics, Teacher Aides, Library Clerks; excluding Supervisors, Technical Aides and Certified Teaching Personnel, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, **RI Council 94, AFSCME, AFL-CIO, Local 2671** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.


