CERTIFICATION OF REPRESENTATIVES

Pursuant to a Consent Election by and between State of Rhode Island and State of Rhode Island Employed Physicians Association and RI Alliance of Social Service Employees, Local 580, SEIU, AFL-CIO, the RI State Labor Relations Board held an election on February 23, 1973 of all full-time physicians employed by the State of Rhode Island in the following Departments: MHRH & SRS and Correctional Services, excluding Chief of Medical Services, General Hospital, Assistant Chief of Medical Services, General Hospital, Chief and Assistant Chief of Psychiatric Services, Institute of IMH, Chief of Medical Services, Dr. Ladd School, Physicians employed by Zambarano Hospital and all other physicians employed by the State of Rhode Island.

On the basis of the election of said employees as aforesaid, the State of Rhode Island Employed Physicians Association had been designated by a majority of said employees of the State of Rhode Island as their bargaining representative.

Pursuant to a Consent Election by and between Zambarano Memorial Hospital and State of Rhode Island Employed Physicians Association, the RI State Labor Relations Board held an election on July 12, 1973 of all physicians employed by Zambarano Memorial Hospital, excluding Clinical Director.

On the basis of the election of said employees as aforesaid, the State of Rhode Island Employed Physicians Association had been designated by a majority of said employees of Zambarano Memorial Hospital as their bargaining representative.

That on April 11, 2025, two (2) Petitions for Affiliation/Merger of Bargaining Representatives were filed with the Board by the State of Rhode Island Employed Physicians Association and RI Council 94, AFSCME, AFL-CIO as well as a request dated May 7, 2025, to update and consolidate certification numbers EE- 2042 and EE- 3003.

That on May 13, 2025, after review and discussion, the RI State Labor Relations Board accepted the request for affiliation/merger of bargaining units as well as the request to update and consolidate certification numbers EE- 2042 and EE- 3003 into EE- 2042A.

THEREFORE, the RI State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that the State of Rhode Island Employed Physicians Association, having agreed to affiliate with RI Council 94, AFSCME, AFL-CIO under the name **Rhode Island Council 94, AFSCME, AFL-CIO, Rhode Island State Employed Physicians Association, Local 2957** shall consist of the following job classifications within the Eleanor Slater Hospital, Department of Behavioral Healthcare, Developmental Disabilities and Hospitals, the Rhode Island Psychiatric Hospital - Department of Behavioral Healthcare, Developmental Disabilities and Hospitals, the Department of Corrections, the Rhode Island Veterans Home - Office of Veterans Services, Department of Human Services: Assistant Medical Program Director (RIVH), Hospitalist (BHDDH), Physician Administrator (Psychiatric)(BHDDH), Physician (General)(BHDDH), Physician II (General), Physician II (General)(RIVH), and Psychiatrist (BHDDH). Notwithstanding the foregoing, supervisory, managerial, and confidential positions are hereby excluded from the above captioned bargaining unit. Without intending to limit the generality of the foregoing, the following positions within the aforesaid departments are hereby excluded from the above-captioned bargaining unit by agreement of the parties: Chief Medical Officer (Rhode Island State Psychiatric Hospital), Chief Medical Officer (BHDDH Eleanor Slater Hospital), and Medical Program Director (Corrections).


