**AMENDED CERTIFICATION OF REPRESENTATIVES**

Pursuant to a Consent Election by and between the **State of Rhode Island – Department of Behavioral Healthcare, Developmental Disabilities & Hospitals – RICLAS** and **RI Council 94, AFSCME, AFL-CIO, Local 1293** and R.I. Alliance of Social Service Employees, Local 580, the Rhode Island State Labor Relations Board held an election on March 23, 1973, by secret ballot of: **(See Attached Sheet)**

On the basis of the election of said employees as aforesaid, **RI Council 94, AFSCME, AFL-CIO, Local 1293** has been designated by a majority of said employees of the **State of Rhode Island – Department of Behavioral Healthcare, Developmental Disabilities & Hospitals – RICLAS**, as their bargaining representative.





Alliance of Social Service Employees, Local 580.


**THEREFORE**, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:


