THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that RI Council 94, AFSCME, AFL-CIO, Local 2873 has been designated and selected by a majority of: All supervisory employees in the Rhode Island Airport Corporation, excluding Assistant Director of Transportation (Airports), Coordinator & Liaison Assistant (Division of Airports), and Chief Clerk, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, RI Council 94, AFSCME, AFL-CIO, Local 2873 is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
