AMENDED CERTIFICATION OF REPRESENTATIVES

Pursuant to a Consent Election by and between **Rhode Island Airport Corporation** and **RI Council 94, AFSCME, AFL-CIO, Local 2873**, the Rhode Island State Labor Relations Board held an election on February 16, 1973, by secret ballot of: All supervisory employees in the **Rhode Island Airport Corporation**, excluding Assistant Director of Transportation (Airports), Coordinator & Liaison Assistant (Division of Airports) and Chief Clerk.

On the basis of the election of said employees as aforesaid, **RI Council 94, AFSCME, AFL-CIO, Local 2873** has been designated by a majority of said employees of the **Rhode Island Airport Corporation**, as their bargaining representative.


That on September 27, 2019, a request was received from Rhode Island State Employees Association, Council 22, AFSCME, AFL-CIO, (**RI Council 94, AFSCME, AFL-CIO**) that the above-entitled certification be amended to reflect the identity change of the party's representatives.

That on October 8, 2019, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the identity change of the party's representatives, to read: **Rhode Island Airport Corporation and RI Council 94, AFSCME, AFL-CIO, Local 2873**.


THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that **RI Council 94, AFSCME, AFL-CIO, Local 2873** has been designated and selected by a majority of: All supervisory employees in the **Rhode Island Airport Corporation**, excluding Assistant Director of Transportation (Airports), Coordinator & Liaison Assistant (Division of Airports), and Chief Clerk, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, **RI Council 94, AFSCME, AFL-CIO, Local 2873** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.




