AMENDED CERTIFICATION OF REPRESENTATIVES

Pursuant to a Consent Election by and between the **State of Rhode Island – Department of Behavioral Healthcare, Developmental Disabilities & Hospitals – Eleanor Slater Hospital – Division of Management Services – Division of Facilities and Maintenance Services**, and Alliance of Rhode Island State Employees/National Association of Government Employees (NAGE) and **RI Council 94, AFSCME, AFL-CIO, Local 2392**, the Rhode Island State Labor Relations Board held an election on December 29, 1975, by secret ballot of: All employees of the Division of Management Services and Division of Facilities and Maintenance Services, excluding Supervisory and Professional Employees.

On the basis of the election of said employees as aforesaid, **RI Council 94, AFSCME, AFL-CIO, Local 2392** has been designated by a majority of said employees of the **State of Rhode Island – Department of Behavioral Healthcare, Developmental Disabilities & Hospitals – Eleanor Slater Hospital – Division of Management Services – Division of Facilities and Maintenance Services**, as their bargaining representative.

That on December 4, 2019, a request was received from AFSCME, Council 70, AFL-CIO, (**RI Council 94, AFSCME, AFL-CIO**) that the above-entitled certification be amended to reflect the identity change of the party's representatives.

That on December 10, 2019, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the identity change of the party's representatives, to read: **State of Rhode Island – Department of Behavioral Healthcare, Developmental Disabilities & Hospitals – Eleanor Slater Hospital – Division of Management Services – Division of Facilities and Maintenance Services** and Alliance of Rhode Island State Employees/National Association of Government Employees (NAGE) and **RI Council 94, AFSCME, AFL-CIO, Local 2392**.

THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that **RI Council 94, AFSCME, AFL-CIO, Local 2392** has been designated and selected by a majority of: All employees of the Division of Management Services and Division of Facilities and Maintenance Services, excluding Supervisory and Professional Employees, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, **RI Council 94, AFSCME, AFL-CIO, Local 2392** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
