AMENDED CERTIFICATION OF REPRESENTATIVES

Pursuant to a Consent Election by and between the **Town of Burrillville** and **RI Council 94, AFSCME, AFL-CIO, Local 186**, the Rhode Island State Labor Relations Board held an election on November 21, 1975, by secret ballot of: Truck Drivers, Highway Maintenance, Equipment Operators and other Highway Personnel, excluding the Director of Public Works and all supervisory personnel as determined by the State Labor Relations Board.

On the basis of the election of said employees as aforesaid, **RI Council 94, AFSCME, AFL-CIO, Local 186** has been designated by a majority of said employees of the **Town of Burrillville** as their bargaining representative.


That on October 1, 2019, a request was received from the Rhode Island Public Employees, Council 70, AFSCME, AFL-CIO, (**RI Council 94, AFSCME, AFL-CIO**) that the above-entitled certification be amended to reflect the identity change of the party's representatives.

That on October 8, 2019, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the identity change of the party's representatives, to read: **Town of Burrillville and RI Council 94, AFSCME, AFL-CIO, Local 186**.


THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that **RI Council 94, AFSCME, AFL-CIO, Local 186** has been designated and selected by a majority of: Truck Drivers, Highway Maintenance, Equipment Operators and other Highway Personnel, excluding the Director of Public Works and all supervisory personnel as determined by the State Labor Relations Board, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, **RI Council 94, AFSCME, AFL-CIO, Local 186** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.


