**AMENDED CERTIFICATION OF REPRESENTATIVES**

Pursuant to an Ordered Election by and between the State of Rhode Island – Board of Regents/University of Rhode Island (URI), RISEA – Council 22, AFSCME, AFL-CIO and the **Educational Support Professionals – University of Rhode Island (URI)/NEARI**, the Rhode Island State Labor Relations Board held an election on June 25, 1976 by secret ballot of: all classified clerical employees, classified librarians and all regularly employed classified part-time employees working sixteen hours or more per week employed by the University of Rhode Island (URI), excluding clerical employees in the President's Office, Vice-President's Office, Personnel Office, one Fiscal Clerk in the Budget Office, limited Appointments, a Confidential Secretary in each Dean's Office and Shirley Maillous.

On the basis of the election of said employees as aforesaid, the **Educational Support Professionals – University of Rhode Island (URI)/NEARI** has been designated by a majority of said employees of the State of Rhode Island – Board of Regents/University of Rhode Island (URI) as their bargaining representative.


That on October 17, 2014, a request was received from the Educational Support Professionals – University of Rhode Island (URI)/ NEARI, that the above-entitled certification be amended to reflect the identity change of the Bargaining Unit Representative from the **RI Educational Association** to the **Educational Support Professionals – University of Rhode Island (URI)/NEARI**.


That on November 5, 2014, after review and discussion, the RI State Labor Relations Board accepted the request for an amendment to this certification, reflecting the change in the Bargaining Unit Representative, to read: **Educational Support Professionals – University of Rhode Island (URI)/NEARI**.


That the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by 28-7-16, General Laws of Rhode Island, 1956, it is hereby:


**CERTIFIED**, that **Educational Support Professionals – University of Rhode Island (URI)/NEARI** has been designated and selected by a majority of all classified clerical employees, classified librarians and all regularly employed classified part-time employees working sixteen hours or more per week employed by the University of Rhode Island (URI), excluding clerical employees in the President's Office, Vice-President's Office, Personnel Office, one Fiscal Clerk in the Budget Office, limited Appointments, a Confidential Secretary in each Dean's Office and Shirley Maillous, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of 28-7-16 of the Act, the **Educational Support Professionals – University of Rhode Island (URI)/NEARI** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.


