CERTIFICATION OF REPRESENTATIVES

Pursuant to a Consent Election by and between the North Providence School Department (employees of the North Providence School Department in the following classifications: office and clerical employees, cafeteria workers, lunchroom program coordinator, lunchroom coordinator clerk, attendants officer and all employees in the above classifications employed under Federal Programs) and the Rhode Island General Council on behalf of Local Union 1033 of the Laborers' International Union of N. A., AFL-CIO, the Rhode Island State Labor Relations Board held an election on March 9, 1976, by Comparison of Signatures of: employees of the North Providence School Department in the following classifications: office and clerical employees, cafeteria workers, lunchroom program coordinator, lunchroom coordinator clerk, attendants officer and all employees in the above classifications employed under Federal Programs employed by the North Providence School Department.


On the basis of the Comparison of Signatures of said employees as aforesaid, the Rhode Island General Council on behalf of Local Union 1033 of the Laborers' International Union of N. A., AFL-CIO, has been designated by a majority of said employees of the North Providence School Department (employees of the North Providence School Department in the following classifications: office and clerical employees, cafeteria workers, lunchroom program coordinator, lunchroom coordinator clerk, attendants officer and all employees in the above classifications employed under Federal Programs) as their collective bargaining representative.

The Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that the Rhode Island General Council on behalf of Local Union 1033 of the Laborers' International Union of N. A., AFL-CIO has been designated and selected by a majority of: employees of the North Providence School Department in the following classifications: office and clerical employees, cafeteria workers, lunchroom program coordinator, lunchroom coordinator clerk, attendants officer and all employees in the above classifications employed under Federal Programs employed by the North Providence School Department, as their sole representative for

the purposes of collective bargaining and that pursuant to the provisions of Section 28-7-16 of the Act, Rhode Island General Council on behalf of Local Union 1033 of the Laborers' International Union of N. A., AFL-CIO is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
