AMENDED CERTIFICATION OF REPRESENTATIVES

Pursuant to a Consent Election by and between the State of Rhode Island – Department of Human Services – Office of Healthy Aging (OHA) (formerly Department of Elderly Affairs) (all employees in the State of Rhode Island – Department of Human Services – Office of Healthy Aging (OHA) (formerly Department of Elderly Affairs) with the title of Principals and the Public Health Nutritionist; excluding the State Building Commissioner and those employees excluded because of inclusion into unit described in Case No. EE-3114) and RI Council 94, AFSCME, AFL-CIO, Local 2883, the Rhode Island State Labor Relations Board held an election on July 19, 1976, by payroll dues deduction verification of: All employees in the State of Rhode Island – Department of Human Services – Office of Healthy Aging (OHA) (formerly Department of Elderly Affairs) with the title of Principals and the Public Health Nutritionist; excluding the State Building Commissioner and those employees excluded because of inclusion into unit described in Case No. EE-3114, as of the week ending July 18, 1976, employed by the State of Rhode Island – Department of Human Services – Office of Healthy Aging (OHA) (former Department of Elderly Affairs).

On the basis of the payroll dues deduction verification of said employees as aforesaid, **RI Council 94**, **AFSCME**, **AFL-CIO**, **Local 2883** has been designated by a majority of said employees of the State of Rhode Island – Department of Human Services – Office of Healthy Aging (OHA) (formerly Department of Elderly Affairs) (all employees in the State of Rhode Island – Department of Human Services – Office of Healthy Aging (OHA) (formerly Department of Elderly Affairs) with the title of Principals and the Public Health Nutritionist; excluding the State Building Commissioner and those employees excluded because of inclusion into unit described in Case No. EE-3114, as of the week ending July 18, 1976), as their collective bargaining representative.

That on April 16, 2020, a request was received from RISEA-Council 22, AFSCME, AFL-CIO (**RI Council 94, AFSCME, AFL-CIO**) that the above-entitled certification be amended to reflect the identity change of the party's representatives.

That on May 19, 2020, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the identity change of the party's representatives, to read: State of Rhode Island – Department of Human Services – Office of Healthy Aging (OHA) (formerly Department of Elderly Affairs) and RI Council 94, AFSCME, AFL-CIO, Local 2883.

THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that **RI Council 94**, **AFSCME**, **AFL-CIO**, **Local 2883** has been designated and selected by a majority of: All employees in the State of Rhode Island – Department of Human Services – Office of Healthy Aging (OHA) (formerly Department of Elderly Affairs) with the title of Principals and the Public Health Nutritionist; excluding the State Building Commissioner and those employees excluded because of inclusion into unit described in Case No. EE-3114, as of the week ending July 18, 1976, employed by the **State of Rhode Island – Department of Human Services – Office of Healthy Aging (OHA) (former Department of Elderly Affairs)**, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, **RI Council 94**, **AFSCME**, **AFL-CIO**, **Local 2883** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
