Pursuant to a Consent Election by and between the **State of Rhode Island – Office of the General Treasurer** and Rhode Island Employment Security Alliance and **RI Council 94, AFSCME, AFL-CIO, Local 2884**, the Rhode Island State Labor Relations Board held an election on Friday, July 23, 1976 by secret ballot of: All classified and unclassified employees of the **State of Rhode Island – Office of the General Treasurer**, excluding top level management and top level supervisory personnel.

That on May 19, 2020, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the identity change of the party's representatives, to read: **State of Rhode Island – Office of the General Treasurer** and Rhode Island Employment Security Alliance and **RI Council 94**, **AFSCME**, **AFL-CIO**, **Local 2884**.

THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that RI Council 94, AFSCME, AFL-CIO, Local 2884 has been designated and selected by a majority of: All classified and unclassified employees of the State of Rhode Island – Office of the General Treasurer, excluding top level management and top level supervisory personnel, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, RI Council 94, AFSCME, AFL-CIO, Local 2884 is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
