AMENDED CERTIFICATION OF REPRESENTATIVES

THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that **RI Council 94**, **AFSCME**, **AFL-CIO**, **Local 2874** has been designated and selected by a majority of: Clerical and Technical employees employed by the **State of Rhode Island – Department of Revenue – Division of Motor Vehicles – Safety & Emission Control**; excluding the Chief and the Assistant Chief, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, **RI Council 94**, **AFSCME**, **AFL-CIO**, **Local 2874** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
