AMENDED CERTIFICATION OF REPRESENTATIVES

Pursuant to a Consent Election by and between the **State of Rhode Island – Department of Revenue – Division of Motor Vehicles – Safety & Emission Control** and **RI Council 94, AFSCME, AFL-CIO, Local 2874**, the Rhode Island State Labor Relations Board held an election on January 5, 1979 by secret ballot of: Clerical and Technical employees employed by the **State of Rhode Island – Department of Revenue – Division of Motor Vehicles – Safety & Emission Control**; excluding the Chief and the Assistant Chief.

On the basis of the election of said employees as aforesaid, **RI Council 94, AFSCME, AFL-CIO, Local 2874** has been designated by a majority of said employees of the **State of Rhode Island – Department of Revenue – Division of Motor Vehicles – Safety & Emission Control**, as their bargaining representative.

That on April 20, 2020, a request was received from Rhode Island Council 94, AFSCME (**Rhode Island Council 94, AFSCME, AFL-CIO**) that the above-entitled certification be amended to reflect the identity change of the party’s representatives.

That on May 19, 2020, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the identity change of the party’s representatives, to read: **State of Rhode Island – Department of Revenue – Division of Motor Vehicles – Safety & Emission Control and RI Council 94, AFSCME, AFL-CIO, Local 2874**.

THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that **RI Council 94, AFSCME, AFL-CIO, Local 2874** has been designated and selected by a majority of: Clerical and Technical employees employed by the **State of Rhode Island – Department of Revenue – Division of Motor Vehicles – Safety & Emission Control**; excluding the Chief and the Assistant Chief, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, **RI Council 94, AFSCME, AFL-CIO, Local 2874** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
