Pursuant to a Consent Election by and between State of R. I., Dept. of Business Regulation, Business Regulation Employees Assn. and R. I. Alliance of Social Service Employees, Local 580, SEIU, AFL-CIO signed by all parties on May 18, 1979 the Rhode Island State Labor Relations Board held an election on June 22, 1979 by secret ballot of all employees employed by the Department of Business Regulation (see attached sheet), excluding only top level supervisory employees.

has been designated by a majority of said employees of the State of Rhode Island, Department of Business Regulation as their bargaining representative.



CERTIFIED, that the RIASSE, Local 580, SEIU, AFL-CIO has been designated and selected by a majority of the all employees employed by the Department of Business Regulation (see attached sheet), excluding only top level supervisory employees

as their sole representative for the purpose of collective bargaining and that pursuant to the provisions of 28-7-16, (1) of the Act, the Rhode Island Alliance of Social Service Employees, Local 580, SEIU, AFL-CIO

is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
