

That on March 17, 2026, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the identity change of the parties' representatives, to read: **Community College of Rhode Island** and **Community College of Rhode Island Professional Staff Association/NEARI/NEA**.

THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by 28-7-16, General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

**CERTIFIED**, that the **Community College of Rhode Island Professional Staff Association/NEARI/NEA** has been designated and selected by a majority of: **(SEE ATTACHED SHEET)** as their sole representative for the purpose of collective bargaining and that pursuant to the provisions of 28-7-16 (1) of the Act; the **Community College of Rhode Island Professional Staff Association/NEARI/NEA** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
