**AMENDED CERTIFICATION OF REPRESENTATIVES**

Pursuant to a Consent Election by and between the **State of Rhode Island, Department of Labor and Training**, R.I. Council 94, AFSCME, AFL-CIO, and **Rhode Island Employment Security Alliance, Local 401, SEIU**, the Rhode Island State Labor Relations Board held an election on September 25, 1980, by secret ballot of:

That on December 14, 2010, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the name change of the Bargaining Unit Representative, to read: **Rhode Island Employment Security Alliance, Local 401, SEIU**.

THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

**CERTIFIED**, that the **Rhode Island Employment Security Alliance, Local 401, SEIU**, has been designated and selected by a majority of: (See Attached Sheet for Unit), as their sole representative for the purpose of collective bargaining and that pursuant to the provisions of §28-7-16 of the Act; that the **Rhode Island Employment Security Alliance, Local 401, SEIU** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
