**AMENDED CERTIFICATION OF REPRESENTATIVES**

Pursuant to a Consent Election by and between the East Greenwich School Committee and the East Greenwich Secretaries and Aides Association/NEARI and RI Council 94, AFSCME, AFL-CIO, the Rhode Island State Labor Relations Board held an election on August 26, 1982, by secret ballot of: Secretaries and Aides.

On the basis of the election of said employees as aforesaid, the East Greenwich Secretaries and Aides Association/NEARI had been designated by a majority of said employees of the East Greenwich School Committee, as their bargaining representative.

That on February 2, 2007, a request was received from the East Greenwich Educational Support Personnel/NEARI/NEA, that the above-entitled Certification be amended to reflect the identity change of the Union, as agreed upon by the parties during negotiations.

That on March 20, 2007, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this Certification, reflecting the change in Union to read: **East Greenwich Educational Support Personnel/NEARI/NEA**.

Therefore, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by 28-7-16, General Laws of Rhode Island, 1956, it is hereby:

CERTIFIED, that the **East Greenwich Educational Support Personnel/NEARI/NEA**, has been designated and selected by a majority of employees to include: Secretaries and Aides, to act as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of 28-7-16 of the Act, **East Greenwich Educational Support Personnel/NEARI/NEA**, is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
