AMENDED CERTIFICATION OF REPRESENTATIVES

Pursuant to an Ordered Election by and between the Foster/Glocester School Committee and the **Ponaganset Association of Educational Support Personnel/NEARI/NEA**, and RI Council 94, AFSCME, AFL-CIO, the Rhode Island State Labor Relations Board held an election on September 13, 1984, by secret ballot of: Clerks, Custodians, Teacher Aides, Bookkeeper, Matrons and Secretaries.

On the basis of the election of said employees as aforesaid, the **Ponaganset Association of Educational Support Personnel/NEARI/NEA** has been designated by a majority of said employees of the Foster/Glocester School Committee as their bargaining representative.

That on January 23, 2013, a request was received from the National Education Association of Rhode Island, NEARI, that the above-entitled Certification be amended to reflect the identity change of the bargaining unit representative.

That on February 12, 2013, after review and discussion, the Rhode Island State Labor Relations Board accepted the request for amendment to the Certification of Representatives, reflecting the change in the Bargaining Unit Representative, to read: **Ponaganset Association of Educational Support Personnel/NEARI/NEA**.

The Rhode Island State Labor Relations Board, by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that the **Ponaganset Association of Educational Support Personnel/NEARI/NEA**, has been designated and selected by a majority of the Clerks, Custodians, Teacher Aides, Bookkeeper, Matrons and Secretaries as their sole representative for the purpose of collective bargaining and that pursuant to the provisions of section 28-7-16 of the Act, the **Ponaganset Association of Educational Support Personnel/NEARI/NEA** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
