AMENDED CERTIFICATION OF REPRESENTATIVES

Pursuant to an Ordered Election by and between the State of Rhode Island – Executive Department – Office of Adjutant General (Military Staff), the Independent Association of Employees and **RI Council 94, AFSCME, AFL-CIO, Local 2886**, dated July 31, 1984, the Rhode Island State Labor Relations Board held an election on August 16, 1984, by secret ballot of: All non-military employees under the Office of Adjutant General and included within account numbers 2031, 2032, 2034, 2035, excluding any and all of those employees deemed to be supervisory, confidential or management type personnel.

On the basis of the election of said employees as aforesaid, **RI Council 94, AFSCME, AFL-CIO, Local 2886** has been designated by a majority of said employees of the State of Rhode Island – Executive Department – Office of Adjutant General (Military Staff) as their bargaining representative.






That on December 18, 2019, a request was received from RI Council 94, AFSCME, AFL-CIO that the above-entitled certification be amended to reflect the identity change of the Union representative.

That on January 14, 2020, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the identity change of the Union representative, to read: State of Rhode Island – Executive Department – Office of Adjutant General (Military Staff) and Independent Association of Employees and **RI Council 94, AFSCME, AFL-CIO, Local 2886**.

THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that **RI Council 94, AFSCME, AFL-CIO, Local 2886** has been designated and selected by a majority of: All non-military employees under the Office of Adjutant General and included within account numbers 2031, 2032, 2034, 2035, excluding any and all of those employees deemed to be supervisory, confidential or management type personnel, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, **RI Council 94, AFSCME, AFL-CIO, Local 2886** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
