Pursuant to an Ordered Election by and between the **State of Rhode Island – RI Council on Post Secondary Education – Rhode Island College** and Association of Clerical/Technical Employees/ NEARI/NEA and **RI Council 94, AFSCME, AFL-CIO, Local 2879**, the Rhode Island State Labor Relations Board held an election on October 19, 1984, by secret ballot of: All classified clerical personnel employed by the **State of Rhode Island – RI Council on Post-Secondary Education – Rhode Island College**, excluding supervisors.

That on May 19, 2020, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the identity change of the party's representatives, to read: **State of Rhode Island – RI Council on Post Secondary Education – Rhode Island College** and Association of Clerical/Technical Employees/ NEARI/ NEA and **RI Council 94, AFSCME, AFL-CIO, Local 2879.**

THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that **RI Council 94**, **AFSCME**, **AFL-CIO**, **Local 2879** has been designated and selected by a majority of: All classified clerical personnel employed by the **State of Rhode Island – RI Council on Post-Secondary Education – Rhode Island College**, excluding supervisors, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, **RI Council 94**, **AFSCME**, **AFL-CIO**, **Local 2879** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
