## **AMENDED CERTIFICATION OF REPRESENTATIVES**

Pursuant to a Consent Election by and between the State of Rhode Island - Department of Health, the Independent Association of Employees and RI Council 94, AFSCME, AFL-CIO, Local 2870, the Rhode Island State Labor Relations Board held an election on Friday, May 29, 1987, by secret ballot of: Employees in the Department of Health, excluding nurses, professional and supervisory employees.

On the basis of the election of said employees as aforesaid, RI Council 94, AFSCME, AFL-CIO, Local 2870 has been designated by a majority of said employees of the State of Rhode Island -Department of Health as their bargaining representative.

That on December 18, 2019, a request was received from RI Council 94, AFSCME, AFL-CIO that the above-entitled certification be amended to reflect the identity change of the Union representative.

That on January 14, 2020, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the identity change of the Union representative, to read: State of Rhode Island – Department of Health and Independent Association of Employees and RI Council 94, AFSCME, AFL-CIO, Local 2870.

THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that RI Council 94, AFSCME, AFL-CIO, Local 2870 has been designated and selected by a majority of: Employees in the Department of Health, excluding nurses, professional and supervisory employees, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, RI Council 94, AFSCME, AFL-CIO, Local 2870 is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
