## AMENDED CERTIFICATION OF REPRESENTATIVES

Pursuant to a Consent Election by and between the Town Of Scituate, the International Brotherhood of Police Officers and the Fraternal Order of Police, Lodge #30, the Rhode Island State Labor Relations Board held an election on Tuesday, July 14, 1987, by secret ballot of: All regular full-time police officers as defined in Title 28-9.2-3 of the General Laws of the State of Rhode Island, 1956, as amended.

On the basis of the election of said employees as aforesaid, the International Brotherhood of Police Officers has been designated by a majority of said employees of the Town of Scituate, as their bargaining representative.

That on November 4, 2005, the Town of Scituate submitted to the RI State Labor Relations Board, correspondence and a Stipulation Amending Composition of the Bargaining Unit, to amend the Certification of Representatives for clarification of the scope of the aforementioned bargaining unit listed within Case No. EE-3412.

That on December 13, 2005, after review and discussion, the RI State Labor Relations Board accepted the Stipulation Amending Composition of the Bargaining Unit submitted by the Town of Scituate, and approved the amendment of this Certification of Representatives.

**THEREFORE**, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by 28-7-16, General Laws of Rhode Island, 1956, it is hereby:

**CERTIFIED**, that the International Brotherhood of Police Officers, has been designated and selected by a majority of: All full-time permanent police officers from the rank of Patrolman up to and including police officers holding the rank of Sergeant, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of 28-7-16 of the Act, the International Brotherhood of Police Officers, is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
