**AMENDED CERTIFICATION OF REPRESENTATIVES**

Pursuant to a Consent Election by and between the State of Rhode Island Community College of Rhode Island, RI Council 94, AFSCME, AFL-CIO, and **Educational Support Professional Association/CCRI/NEARI**, the Rhode Island State Labor Relations Board held an election on Friday, September 18, 1987, by secret ballot of: All classified employees employed by Community College of Rhode Island excluding professional, confidential and supervisory personnel as determined by the Rhode Island State Labor Relations Board but including regular part-time employees working twenty hours or more per week.

On the basis of the election of said employees as aforesaid, the **Educational Support Professional Association/CCRI/NEARI** has been designated by a majority of said employees of the State of Rhode Island Community College of Rhode Island as their bargaining representative.





That on January 23, 2013, a request was received from the National Education Association of Rhode Island, NEARI, that the above-entitled Certification be amended to reflect the identity change of the Bargaining Unit Representative.

That on February 12, 2013, after review and discussion, the Rhode Island State Labor Relations Board accepted the request for amendment to the Certification of Representatives, reflecting the change in the Bargaining Unit Representative, to read: **Educational Support Professional Association/CCRI/NEARI**.

The Rhode Island State Labor Relations Board, by virtue of and pursuant to the powers vested in said Board by 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

**CERTIFIED**, that the **Educational Support Professional Association/CCRI/NEARI**, has been designated and selected by a majority of all classified employees employed by the Community College of Rhode Island excluding professional, confidential and supervisory personnel as determined by the Rhode Island State Labor Relations Board but including regular part-time employees working twenty hours or more per week, as their sole representative for the purpose of collective bargaining and that pursuant to the provisions of section 28-7-16 of the Act, the **Educational Support Professional Association/CCRI/NEARI** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
