AMENDED CERTIFICATION OF REPRESENTATIVES

Pursuant to a Consent Election by and between the **State of Rhode Island – University of Rhode Island Board of Trustees - URI** and Teamsters Local Union No. 251 and **RI Council 94, AFSCME, AFL-CIO, Local 528**, the Rhode Island State Labor Relations Board held an election on August 6 and 7, 1987, by secret ballot of: Employees employed by the **State of Rhode Island – University of Rhode Island Board of Trustees - URI** including the U.R.I. Extension Employees, Adult Education and Alton Jones and School of Oceanography Employees (Marine Lab.), excluding clerks, professional employees and supervisory employees.

On the basis of the election of said employees as aforesaid, **RI Council 94, AFSCME, AFL-CIO, Local 528** has been designated by a majority of said employees of the **State of Rhode Island – University of Rhode Island Board of Trustees - URI** as their bargaining representative.

That on April 15, 2020, a request was received from Rhode Island Council 94, AFSCME, AFL-CIO that the above-entitled certification be amended to reflect the identity change of the party's representatives.

That on May 19, 2020, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the identity change of the party's representatives, to read: **State of Rhode Island – University of Rhode Island Board of Trustees – URI** and Teamsters Local Union No. 251 and **RI Council 94, AFSCME, AFL-CIO, Local 528**.

THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that **RI Council 94, AFSCME, AFL-CIO, Local 528** has been designated and selected by a majority of: Employees employed by the **State of Rhode Island – University of Rhode Island Board of Trustees - URI** including the U.R.I. Extension Employees, Adult Education and Alton Jones and School of Oceanography Employees (Marine Lab.), excluding clerks, professional employees and supervisory employees, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, **RI Council 94, AFSCME, AFL-CIO, Local 528** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
