AMENDED CERTIFICATION OF REPRESENTATIVES

Pursuant to a Consent Election by and between the **State of Rhode Island – Department of Public Safety – Division of Sheriffs, RI Council 94, AFSCME, AFL-CIO, Local 2409**, and the International Brotherhood of Police Officers (IBPO), the Rhode Island State Labor Relations Board held an election on Wednesday, September 5, 2001 by secret ballot of:

As currently defined in Case No. EE-3418 – “all Sheriffs, Deputy to the Sheriff, Deputy Sheriff, Deputy Sheriff and Clerk, Clerk Deputy (Female), Clerk, Clerical, Clerk Typist, Matron employed by the State of Rhode Island, excluding High Sheriffs, Deputy Chief and Deputy Sheriffs’ (committing squad)”; and

As currently defined in Case No. EE-3599 – “all Rhode Island State Deputy Marshals.” And the newly created unit shall be the following: Including all Deputy Sheriffs; Deputy Sheriffs II; Deputy Sheriff Sergeants, Lieutenants and Captains; Deputy Sheriff Clerks; Administrative Aides; and Clerks, excluding Administrator, Executive High Sheriff, Sheriffs and Chief Deputy Sheriffs.

NOTE: *The vote of the employee holding the position of Chief Deputy Marshall (Major) will be challenged; and the determination relative to the position of Chief Deputy Marshal (Major) shall be made by the Board at a later date.*

On the basis of the election of said employees as aforesaid, **RI Council 94, AFSCME, AFL-CIO, Local 2409**, has been designated by a majority of said employees of the State of Rhode Island – **Department of Public Safety** – Division of Sheriffs, as their bargaining representative.

That on April 21, 2020, a request was received from RI Council 94, AFSCME, AFL-CIO, that the above-entitled certification be amended to reflect the identity change of the Union Representative.

That on May 19, 2020, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the change in the Union Representative, to read: **RI Council 94, AFSCME, AFL-CIO, Local 2409.**

THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that **RI Council 94, AFSCME, AFL-CIO, Local 2409** has been designated and selected by a majority of:

As currently defined in Case No. EE-3418 – “all Sheriffs, Deputy to the Sheriff, Deputy Sheriff, Deputy Sheriff and Clerk, Clerk Deputy (Female), Clerk, Clerical, Clerk Typist, Matron employed by the State of Rhode Island, excluding High Sheriffs, Deputy Chief and Deputy Sheriffs’ (committing squad)”; and

As currently defined in Case No. EE-3599 – “all Rhode Island State Deputy Marshals.” And the newly created unit shall be the following: Including all Deputy Sheriffs; Deputy Sheriffs II; Deputy Sheriff Sergeants, Lieutenants and Captains; Deputy Sheriff Clerks; Administrative Aides; and Clerks, excluding Administrator, Executive High Sheriff, Sheriffs and Chief Deputy Sheriffs, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, **RI Council 94, AFSCME, AFL-CIO, Local 2409** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
