CERTIFICATION OF REPRESENTATIVES

Pursuant to an Ordered Election by and between the State of Rhode Island, Department of Corrections and Rhode Island Laborers' District Council, on behalf of the Rhode Island Judicial, Professional and Technical Employees, Local Union 808, L.I.U.N.A. the Rhode Island State Labor Relations Board held an election on May 18, 1992

by secret ballot of Associate Directors assigned to the Department of Corrections and excluding all other employees.

On the basis of the election of said employees as aforesaid, the Rhode Island Laborers' District Council, on behalf of the Rhode Island Judicial, Professional and Technical Employees, Local Union 808, L.I.U.N.A. has been designated by a majority of said employees of the State of Rhode Island, Department of Corrections as their bargaining representative.

The Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 6, of the Rhode Island State Labor Relations Act, Chapter 1066 of the Public Laws of 1941, as amended, it is hereby:

CERTIFIED, that the Rhode Island Laborers' District Council, on behalf of the Rhode Island Judicial, Professional and Technical Employees, Local Union 808, L.I.U.N.A. has been designated and selected by a majority of the Associate Directors assigned to the Department of Corrections and excluding all other employees,

as their sole representative for the purpose of collective bargaining and that pursuant to the provisions of Section 6, subdivision 1, of the Act, the Rhode Island Laborers' District Council, on behalf of the Rhode Island Judicial, Professional and Technical Employees, Local Union 808, L.I.U.N.A. is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
