AMENDED CERTIFICATION OF REPRESENTATIVES

Pursuant to a Consent Election by and between the State of Rhode Island, Department of Public Defender, Independent Employees Association, and **RI Laborers' District Council, Local 808**, the Rhode Island State Labor Relations Board held an election on July 13, 1989, by secret ballot of: All employees assigned to the Public Defender's Office, namely, Chief Investigator, Investigator, Systems Analyst Investigator, Polygraph Examiner, Legal Secretary, Principal Clerk Stenographer, Interpreter Aide and Secretary, excluding all positions not covered by the Act.

On the basis of the election of said employees as aforesaid, **RI Laborers' District Council, Local 808**, has been designated by a majority of said employees of the State of Rhode Island – Department of Public Defender, as their bargaining representative.

That on April 16, 2007, **RI Laborers' District Council, Local 808**, submitted to the RI State Labor Relations Board, a Consent Agreement and Affidavit requesting an amendment to the current composition of the aforementioned Bargaining Unit; as well as a request to amend the Certification of Representatives for Case No. EE-3451. The new Bargaining Unit shall reflect the following changes in position titles, to wit: **Deputy Chief Investigator; Investigator I; Investigator II; Administrative Secretary; Confidential Secretary & Office Manager; Data Entry Aide; Case Management Coordinator; Social Services Caseworker; Supervising Clerk; Clerical; Legal Secretary I; Legal Secretary II; and Administrative Support Specialist, excluding all positions not covered by the Act.**

That on May 8, 2007, after review and discussion, the RI State Labor Relations Board accepted the Consent Agreement and Affidavit amending the composition of the Bargaining Unit submitted by the **RI Laborers' District Council, Local 808**, and approved the amendment of the Certification of Representatives.

The Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by 28-7-16, General Laws of Rhode Island, 1956, it is hereby:

CERTIFIED, that **RI Laborers' District Council, Local 808**, has been designated and selected by a majority of: All employees assigned to the Public Defender's Office, namely, **Deputy Chief Investigator; Investigator I; Investigator II; Administrative Secretary; Confidential Secretary & Office Manager; Data Entry Aide; Case Management Coordinator; Social Services Caseworker; Supervising Clerk; Clerical; Legal Secretary I; Legal Secretary II; and Administrative Support Specialist**, as their sole representative for the purpose of collective bargaining and that pursuant to the provisions of 28-7-16 of the Act, the **RI Laborers' District Council, Local 808**, is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
