AMENDED CERTIFICATION OF REPRESENTATIVES

Pursuant to a Consent Election by and between the State of Rhode Island – Department of Transportation – Division of Highway and Bridge Maintenance – Washington South and RI Council 94, AFSCME, AFL-CIO, Local 1245, the Rhode Island State Labor Relations Board held an election on June 27, 1989 by secret ballot of: All employees, excluding the Superintendent and the Foreman in the State of Rhode Island – Department of Transportation – Division of Highway and Bridge Maintenance – Washington South.

THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that **RI Council 94**, **AFSCME**, **AFL-CIO**, **Local 1245** has been designated and selected by a majority of: All employees, excluding the Superintendent and the Foreman in the State of Rhode Island – Department of Transportation – Division of Highway and Bridge Maintenance – Washington South, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, **RI Council 94**, **AFSCME**, **AFL-CIO**, **Local 1245** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
