AMENDED CERTIFICATION OF REPRESENTATIVES

Pursuant to an Ordered Election by and between the Town of Charlestown – Police Department and the **Rhode Island Judicial, Professional and Technical Employees’ Local Union 808**, the Rhode Island State Labor Relations Board held an election on November 15, 1990, by secret ballot of: all Police Dispatchers, Secretaries and Clerks.

On the basis of the election of said employees as aforesaid, the **Rhode Island Judicial, Professional and Technical Employees’ Local Union 808**, has been designated by a majority of said employees of the Town of Charlestown – Police Department, as their bargaining representative.

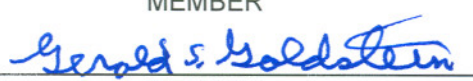
That on July 9, 2009, a request was received from the **Rhode Island Judicial, Professional and Technical Employees’ Local Union 808**, that the above-entitled certification be amended to reflect the identity change of the Bargaining Unit Representative.

That on August 18, 2009, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the change in the Bargaining Unit Representative, to read: **Rhode Island Judicial, Professional and Technical Employees’ Local Union 808**.

THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by **Section 28-7-16, of the General Laws of Rhode Island, 1956**, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that the **Rhode Island Judicial, Professional and Technical Employees’ Local Union 808**, has been designated and selected by a majority of: all Police Dispatchers, Secretaries and Clerks, as their sole representative for the purpose of collective bargaining and that pursuant to the provisions of **§28-7-16** of the Act; that the **Rhode Island Judicial, Professional and Technical Employees’ Local Union 808** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
