CERTIFICATION OF REPRESENTATIVES

Pursuant to a Consent Election by and between the Cumberland Housing Authority (All Clerical and Maintenance employees, Section 8 Coordinator, Accountant, Administrative Assistant, Clerks, Clerk Typists, all Maintenance employees such as Maintenance Aides, Maintenance Laborers, Laborers and Mechanics) and the Rhode Island Laborers' District Council on behalf of LU-1217, the Rhode Island State Labor Relations Board held an election on November 7, 1990, by Comparison of Signatures of: All Clerical and Maintenance employees, Section 8 Coordinator, Accountant, Administrative Assistant, Clerks, Clerk Typists, all Maintenance employees such as Maintenance Aides, Maintenance Laborers, Laborers and Mechanics.

On the basis of the Comparison of Signatures of said employees as aforesaid, the Rhode Island Laborers' District Council on behalf of LU-1217 has been designated by a majority of said employees of the Cumberland Housing Authority (All Clerical and Maintenance employees, Section 8 Coordinator, Accountant, Administrative Assistant, Clerks, Clerk Typists, all Maintenance employees such as Maintenance Aides, Maintenance Laborers, Laborers and Mechanics) as their collective bargaining representative.

The Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that the Rhode Island Laborers' District Council on behalf of LU-1217 has been designated and selected by a majority of: All Clerical and Maintenance employees, Section 8 Coordinator, Accountant, Administrative Assistant, Clerks, clerk Typists, all Maintenance employees such as Maintenance Aides, Maintenance Laborers, Laborers, and Mechanics, as their sole representative for the purpose of collective bargaining and that pursuant to the provisions of Section 28-7-16 of the Act, the Rhode Island Laborers' District Council on behalf of LU-1217 is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
