AMENDED
CERTIFICATION OF REPRESENTATIVES

Pursuant to an Ordered Election by and between the Woonsocket Housing Authority and the International Brotherhood of Teamsters, Local Union #64 the Rhode Island State Labor Relations Board held an election on December 10, 1992 by secret ballot of those employees in the class positions of Comptroller, Senior Housing Manager, Housing Managers, and System Administrator employed by the Woonsocket Housing Authority, excluding all other employees employed by the Woonsocket Housing Authority ****EXCLUDING DIRECTOR OF MODERNIZATION/DEVELOPMENT AND EXCLUDING EXECUTIVE SECRETARY TO THE DIRECTOR****

On the basis of the election of said employees as aforesaid, the **General Teamsters Local 251** has been designated by a majority of said employees of the Woonsocket Housing Authority as their bargaining representative.

That on April 13, 2017, a request was received from the **General Teamsters Local 251**, that the above-entitled certification be amended to reflect the name change of the Bargaining Unit Representative.

That on June 6, 2017, after review and discussion, the Rhode Island State Labor Relations Board accepted the request for amendment to this certification, reflecting the change in Bargaining Unit Representative name, to read: **General Teamsters Local 251**.

The Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 6, of the Rhode Island State Labor Relations Act, Chapter 1066 of the Public Laws of 1941, as amended, it is hereby:

CERTIFIED, that the **General Teamsters Local 251** has been designated and selected by a majority of those employees in the class positions of Comptroller, Senior Housing Manager, Housing Managers, and System Administrator employed by the Woonsocket Housing Authority, excluding all other employees employed by the Woonsocket Housing Authority ****EXCLUDING DIRECTOR OF MODERNIZATION/DEVELOPMENT AND EXCLUDING EXECUTIVE SECRETARY TO THE DIRECTOR**** as their sole representative for the purpose of collective bargaining and that pursuant to the provisions of Section 6, subdivision 1, of the Act, the **General Teamsters Local 251** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
