Training School for Girls, excluding supervisory and professional personnel, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, RI Council 94. AFSCME, AFL-CIO, Local 314 is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
