AMENDED CERTIFICATION OF REPRESENTATIVES

Pursuant to a Consent Election by and between the **State of Rhode Island – Department of Children, Youth and Families – Youth Detention Center**, the RI Brotherhood of Correctional Officers and **RI Council 94, AFSCME, AFL-CIO, Local 314**, the Rhode Island State Labor Relations Board held an election on July 31, 1992 by secret ballot of: All employees at the R.I. Training School for Boys, R.I. Training School for Girls, excluding supervisory and professional personnel.

On the basis of the election of said employees as aforesaid, **RI Council 94, AFSCME, AFL-CIO, Local 314** has been designated by a majority of said employees of the **State of Rhode Island – Department of Children, Youth and Families – Youth Detention Center**, as their bargaining representative.


That on December 18, 2019, a request was received from RI Council 94, AFSCME, AFL-CIO that the above-entitled certification be amended to reflect the identity change of the party's representatives.

That on January 14, 2020, after review and discussion, the RI State Labor Relations Board accepted the request for amendment to this certification, reflecting the identity change of the party's representatives, to read: **State of Rhode Island – Department of Children, Youth and Families – Youth Detention Center** and RI Brotherhood of Correctional Officers and **RI Council 94, AFSCME, AFL-CIO, Local 314**.


THEREFORE, the Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by Section 28-7-16, of the General Laws of Rhode Island, 1956, entitled State Labor Relations Act, it is hereby:

CERTIFIED, that **RI Council 94, AFSCME, AFL-CIO, Local 314** has been designated and selected by a majority of: All employees at the R.I. Training School for Boys, R.I. Training School for Girls, excluding supervisory and professional personnel, as their sole representative for the purpose of collective bargaining; and that pursuant to the provisions of §28-7-16 of the Act, **RI Council 94, AFSCME, AFL-CIO, Local 314** is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.


