CERTIFICATION OF REPRESENTATIVES

Pursuant to an Ordered Election by and between the Town of North Kingstown and the National Education Association Rhode Island/NEARI, the Rhode Island State Labor Relations Board held an election on Thursday, November 6, 1997, by secret ballot of the Town Engineer, Engineering Inspector, Director of Planning and Development, Principal Planner, Principal Planner/Environmental Coordinator, Director of Welfare, Building Official, Director of Senior Services, Assistant Library Director, Operations Manager, Golf Course Superintendent, Deputy Town Clerk, and Director of Community Development; but excluding Executive Secretary, Director of Public Works, Highway Superintendent, Finance Director, Controller, Tax Assessor, Recreation Director, Town Clerk and Director of Water Supply.

On the basis of the election of said employees as aforesaid, the National Education Association Rhode Island/NEARI has been designated by a majority of said employees of the Town of North Kingstown as their bargaining representative.

The Rhode Island State Labor Relations Board by virtue of and pursuant to the powers vested in said Board by 28-7-16, General Laws of Rhode Island, 1956, it is hereby:

CERTIFIED, that the National Education Association Rhode Island/NEARI has been designated and selected by a majority of the Town Engineer, Engineering Inspector, Director of Planning and Development, Principal Planner, Principal Planner/Environmental Coordinator, Director of Welfare, Building Official, Director of Senior Services, Assistant Library Director, Operations Manager, Golf Course Superintendent, Deputy Town Clerk, and Director of Community Development; but excluding Executive Secretary, Director of Public Works, Highway Superintendent, Finance Director, Controller, Tax Assessor, Recreation Director, Town Clerk and Director of Water Supply, as their sole representative for the purpose of collective bargaining and that pursuant to the provisions of 28-7-16 of the Act, the National Education Association Rhode Island/NEARI is the exclusive bargaining representative of said employees for the purposes of collective bargaining with respect to rates of pay, hours of employment and other conditions of employment.
